Main sewer line repair by a contractor and \$2,112 was the balance of the annual premium for liability insurance. Hallinan stated that the annual financial report has been submitted to the Auditor of State and is available for review in the Village office. It will be posted on the web site.

A draft of the proposed 2017 Appropriations Budget was distributed. A permanent budget will be presented for adoption at the March meeting.

5. MAYOR'S REPORT

Kyle Travis has resigned his Council position due to work schedule conflicts. Welcome to new Council member, Rochelle Morgan, who was sworn in prior to this meeting. Also, Phil Garland is teaching a night class for the next few months and will be unable to attend.

Ron reported that DP&L has recently repaired all street lights, with one possible exception. They plan to return soon to finish it.

6. PUBLIC

Resident John Caudill of 227 Flynn St. described flooding which takes place in his back yard and inquired if the Village has plans to address the problem. Herron stated that he had previously spoken with Mr. Caudill on the phone and made him aware of repairs which had been made to the tile system over the past 8 to 10 years. The situation is currently much better than it has been for many years. Ponding taking place now is the result of the 1898 tile system's capacity limitations. The Village has in the past discussed the installation of a storm overflow across Flynn and Council had considered future funding for the project. Mr. Caudill proposed that the Village settle the issue, possibly by buying him out. Herron stated that the Village has no responsibility for storm water entering that area and that improvements made in the past were voluntary. He stated that he would keep Mr. Caudill informed of any developments.

7. VILLAGE ADMINISTRATOR'S REPORT

The Champaign County Engineer is changing the resurfacing cycle from every three years to every two years. A copy of the specific proposal for Woodstock was distributed to Council members. Herron recommended that the Village not chip and seal this cycle because the current condition of the surfaces doesn't warrant it. The new shorter cycle will place us on the schedule again in 2019. Some minor crack sealing would take place this year. Pavement will be more closely inspected before the next meeting to confirm its condition.

The LUC Regional Planning Commission provides services related to zoning and grant application review. Based on population, Woodstock is assessed their minimum fee which is \$487.50. A contact form was distributed to Council members for those interested in receiving mail or e-mail communications from the commission.
