4. FISCAL OFFICER REPORT

Total receipts for the month of May were \$16,933.66 and expenditures were paid for the month totaling \$16,189.05. Expenditures included \$7,280 for a lift station pump and \$2,210 for supplies and labor to prep and paint the municipal building exterior walls.

The 2015 – 2016 State audit report was approved this week by the Auditor's office. There was one negative finding - that "then and now" purchase orders were not always used when appropriate. This has been corrected. The report will be posted on the web site. The cost is expected to be about \$4,000.

5. MAYOR'S REPORT

Both dumpsters filled quickly during community cleanup. There were some prohibited items that had to be pulled out. Rather than three 10-yd. containers, the contractor provided two 20-yd. containers for the same price. The Village may want to have another cleanup day in the Fall.

6. PUBLIC

7. VILLAGE ADMINISTRATOR'S REPORT

Rush Township is applying for an ODOT grant for signs. Municipalities within the township are able to piggyback the application so the Village requested seventeen new high-reflective stop signs, sixteen red sign post reflectors, fourteen 25 MPH speed limit signs, and two 10 MPH speed limit signs. They will be used mostly to replace existing signs.

Municipal building exterior walls were repaired and painted. Pat Brown is willing to move ahead with the mural soon. Although she won't bill the Village for her work, the Village would pay for paint, supplies, and scaffolding if needed. She'll provide a draft for Council to approve before proceeding.

8. OLD BUSINESS

Zizzo stated that are problems with a storm drain on E. Bennett. Herron stated that the problem is that the line is plugged. About three years ago Wiseman attempted to run a jetter through the line but hit an obstruction at about 30 ft. They were unable to power through it. Two options are to run a camera into the line or excavate where we think the obstruction is. Herron will find a camera contractor for \$200 to \$500. There are concerns about excavating because the property appears to be in foreclosure.

Zizzo moved and seconded by Metz to authorize entry onto the property, the repairs, and return of the property to its original or better condition when finished.
