Bart Stokes and Nathan Holycross, representing the North Lewisburg Firemen's Association, stated that the association is assuming responsibility for the annual fireworks display from Triad Junior Baseball. The display will be held this year on July 11. They stated that they are

soliciting contributions to fund the event and asked if the Village would contribute. They intend to expand revenue-generating activities to fund a \$3,000 event. Leftover money would be carried over to the next year. A dedicated account is to be set up. The possibility of changing the name of the association to something reflecting the fact that other municipalities are part of the district was also briefly discussed.

Addresses on West Bennett. The annexation of property on West Bennett last year has created the need to assign new addresses consistent with existing numbering on West Bennett.
