Brad Bodenmiller with the LUC Regional Planning Commission introduced himself and explained some of the organization's services, including consultations, customized maps, and hosting local zoning codes on the Commission's website (www.lucplanning.com). The website also includes contact information. In response to a question, he referred to Dave Gulden and the website about specific median income limits for qualifying for CDBG grants. 6. MAYOR'S REPORT
