7. VILLAGE ADMINISTRATOR'S REPORT

As discussed briefly at the last meeting, 4,480 ft. of tile leaving town to the east was recently replaced. Council has been requested to pay \$1,251 as a share of the cost. Shares were calculated on acreage served. Most of Woodstock's share is based on the ballpark. Weidner objected to not being asked beforehand. Herron agreed but stated that the amount is a bargain given the benefit to significant parts of the Village and recommends that we participate in the cost.

Belcher moved and seconded by Zizzo to pay \$1,251 to Slemmons Excavating for replacement of a section of the Hay Run Ditch main tile east of the Village. Floor is open for discussion on motion. The County Engineer is doing chip & seal in our part of the county this year at a cost of around \$25,000. It's been six years since we've had this done and approval has been given to proceed.

A contract was signed with an electrical contractor to replace electrical components and mounting hardware at a cost of \$17,000 at the lift station. This would include connecting the flowmeter.

Members of Council were informed earlier via e-mail that the creek bed at the treatment plant has shifted exposing about 2 feet of our 6" force main. Slemmons stated that it could be corrected for about \$15-20,000.

Zizzo moved and seconded by Weidner to pay approximately \$19,000 to replace about 40 feet of our 6" force main in the area of Spain Creek to minimize the possibility that the line could be damaged by debris floating downstream.
