#### 7. VILLAGE ADMINISTRATOR'S REPORT

Herron reported that he had been contacted by engineer Pete Hodapp with Kramer & Associates regarding installation of culverts under Flynn St. The Village may be able to pursue a Community Development Block Grant (CDBG) from Champaign County for the project, or possibly an OPWC grant funds depending on whether their program is currently in the year for village projects. Another option **would** be a Small Government Capital Improvement Grant. This is the program used to fund the 559 project in 2014. Mr. Hodapp was told that we would like to begin the application process. The engineering for this project has already been done, so no cost related to design would be incurred at this time.

John Caudill contacted Herron after a recent rainfall since the last Council meeting to express again his concern about the standing water on his property.

#### 8. OLD BUSINESS

Metz expressed concern about the continued presence of the burned out trailer on South Main St. It's believed that the trailer represents a hazard, especially to children, and is unsightly. Herron stated that existing code permits recovery by a municipality of costs related to abatement. Rather than pursuing legal options at this time however, he recommended communicating again with the property owner and agreed to do so.

Discussion of sewer billing procedures for multi-resident properties was tabled pending the presence of all six members of Council.
