FISCAL OFFICER REPORT
Total receipts for the month of February were \$12,057.75 and expenditures were paid for the month totaling \$10,892.39. Receipts were not unusual. Expenses included \$2,500 for a hotapping tool to facilitate connections to our pressurized sewer lines, \$645 in Solicitor fees, and

We were contacted by the independent accounting firm who will be conducting the State audit this year. Basic issues were discussed but no schedule was agreed on.

Resolution 2023-06R proposes membership in the State cooperative purchasing program. This became necessary when John Deere revealed after the fact that their quote was contingent on membership. Membership has a one year term and the cost is minimal. We won't likely use the membership again, but we're being told that the cost of the tractor would be 25% higher without membership.

Ordinance 2023-01 is acceptance of the proposed permanent annual appropriations budget. A copy of it has been distributed.

7. VILLAGE ADMINISTRATOR'S REPORT

All members received copies of the e-mail exchange with North Lewisburg regarding the leak at their treatment plant. They initially attributed the leak to our line, but later determined that the source was a pond on their site. Exception was taken to the casual way the leak was originally communicated, especially given their description of it as raw sewage flowing directly into Spain Creek.

A storm tile on South Main has been in need of repair since last year. Dustin Funderburg was supposed to work on it then, but didn't get to it. He recently stated that he has the tile and will work on it soon.

The new home on South Main was connected to the sewer system early last week. The new hot tap tool was used. The new residents should be moving in soon if they're not already in.

Alison Boggs has been asked to request copies of any correspondence between the Ohio EPA and North Lewisburg since January, 2022, because of its potential value in negotiations.

8. <u>OLD BUSINESS</u>

Alison Boggs stated that she had sent a public records request to North Lewisburg's attorney asking for all UAN reports from 2009 to present, meeting minutes from December 12, 2022, to include any discussion leading to passage of the ordinance increasing the Woodstock fee, and a copy of the ordinance. A letter containing Woodstock's \$24 counteroffer was also sent. A response was then received from a new attorney with Bricker & Eckler stating that our request for UAN reports was too vague. Hallinan stated that he had created a list of report titles that should satisfy that complaint. He also stated that UAN only keeps data for 7 years and reports not printed at an earlier time can't be produced. The new attorney, Christopher Gordon, also stated that any offers or counteroffers previously made by North Lewisburg are rescinded.

Belcher moved and seconded by Current to enter executive session to discuss possible litigation.
