Zizzo stated that there appears to be problem with the way the drain line from his home to the grinder was installed and that settling has occurred. Herron stated that the system was installed in 1998 and the any contractor warranty has long since expired. The contractor made several repairs at no cost long after the warranty expired. Given the elapsed time, the number of installations possibly involved, and the possibility that other factors may have contributed, the Village isn't able to cover repair costs.

Travis asked about the status of talks with Columbia Gas. Herron mentioned recent news stories about poor customer service from Columbia, and that one option for the Village would be to hire an engineer to investigate what the options are for bringing natural gas to the Village. Herron will check into the use of an engineer.
