7. VILLAGE ADMINISTRATOR'S REPORT

The OPWC grant application has been scored at the County and District level. A printout of the scoring was made available to Council at this meeting. It scored higher than any other project in the County and approval is likely. Final word is expected in September.

While seeking more favorable pricing on the 12 new grinder pumps, it was found that there is a \$50/unit price break at 15 units. We ordered 15 and they've already been delivered.

The Fire District purchased a replacement for its 2004 model ambulance from a municipality in Pennsylvania for about \$70,000. These vehicles generally cost between \$180-220K new. This unit was available because the seller routinely replaces its vehicles on a 3-year schedule. It was purchased with a 14-day trial period and 2 years remaining on the original factory warranty. It has about 50,000 miles on it.
